#### Introduction

Department of Tourism, Government of Madhya Pradesh came up with 4 schemes, that can provide opportunities to the house owners of urban and rural areas who are willing to accommodate domestic and international visitors in some portion of their house. These schemes will enable property owners to introduce tourists to the rich culture, cuisine, customs and lifestyle of the *Heart of Incredible India*. Also, these schemes will ensure recurring source of income for property owners and will generate employment opportunities.

To supplement the available tourist accommodation in cities, villages and places near to tourist interest in the state, Madhya Pradesh Tourism has introduced Home Stay establishment schemes-

- Homestay Establishment (Registration and Regulation) Scheme 2010 (revised 2018)
- Bed and Breakfast Establishment (Registration and Regulation) Scheme 2019
- Farm Stay Establishment (Registration and Regulation) Scheme 2019
- Gram Stay Establishment (Registration and Regulation) Scheme 2019

### Why you start a Homestay?

- 1. If you are a retired person, a businessperson, a medical practitioner etc, who likes networking and sharing experiences then, you can start a homestay.
- 2. If you want to join the fast-growing tourism Industry and want to earn extra income at home, through tourism along with your current work.
- 3. If you like to interact with people, and introduce them about your culture, food, clothing, local music, art-handicrafts and traditions.
- 4. If you are practitioners of traditional Indian practices such as Yoga, Naturopathy, Wellness Centre and want to benefit tourists through it.
- 5. If your house has at least 01 and maximum 06 additional rooms and you are willing to earn extra income through the rooms by letting them out for tourists.
- 6. If you want to grow your business through networking and willing to interact with people of other cities / countries.

Then, the Homestay Schemes are suitable for you.



#### **About Scheme**

# Homestay Establishment (Registration and Regulation) Scheme 2010 (revised 2018):

The scheme is introduced for providing comfortable home stay facilities to supplement the available accommodation for tourists to experience the reputed Indian hospitality, cuisine, customs and traditions by staying with Indian families. Homestay owner resides in the same premises, and spares a portion of it for homestay facility.

## Bed and Breakfast Establishment (Registration and Regulation) Scheme 2019:

Under this scheme, additional space of residential property holders in urban areas can be used for tourist accommodation, in which either the property holder / caretaker resides. Property holder has to provide accommodation and breakfast / food etc.

#### Farm stay Establishment (Registration and Regulation) Scheme 2019:

Farm stay means a residential building situated outside the boundary of the municipal corporation in which the property holder / caretaker resides. In such farm stays, tourists will get an opportunity to experience accommodation in natural environment, catering and various recreational and nature related activities.

#### Gram Stay Establishment (Registration and Regulation) Scheme 2019:

Gram Stay means residential buildings located in the Gram Panchayat area where the home owner resides or a registered cooperative society or a registered self-help group for tourist accommodation may operate the unit. Tourist shall get the experience of rural culture, environment, food etc.

### **Required Registration Criteria**

- Purely residential unit, in which the unit owner or caretaker physically resides and a separate kitchen is operated.
- Homeowner may offer a minimum of one room and maximum of six rooms for tourists, except the rooms required for personal use.
- Suitable and comfortable facilities like bathrooms, toilets, water, power supply, furniture etc. in the unit. The unit should have window and proper ventilation.
- The Homestay should be in a good condition and with proper sanitation along with adequate arrangements for security including fire protection and accessibility.
- Same property holder cannot register separate bed and breakfast units in the same premises / colony / building.









### **Registration Process**

Property holders may register their unit either by themselves or through MP Online kiosks, in a very simple and easy online process.
